The studios are intended to function as a space for working artists and cultural industries to develop creatively within a community of like-minded professionals. While we do not require attendance during set hours each day, we do expect that artists will utilize the studios as much as possible and be present at important events, as periodically established and designated by management. In the event that you are unable to attend an event, you will need to alert management and make arrangements for your studio to be open and supervised in your absence. Failure to comply with our attendance policy may result in non-renewal or termination of your lease agreement.

Parking:

You are welcome to park in the Rose Theatre Parking Garage where there is free parking for up to an hour. Beaux Arts Brampton does not provide parking.

Security Deposit:

A security deposit equal to one month's rent is required. This security deposit are payable in full at lease execution.

Rent:

One full month's rent is due at lease signing in order to procure keys. Pro-rated rent, if applicable, is due the first day of the following month. Monthly rent is due the first of each month. If rent is not received by the 5th of the month, a 10% late fee will be charged. If rent is late more than 3 times in a 12 months period, your lease may be terminated.

No Smoking:

Smoking is not allowed in the studios or in any common areas inside or outside of the building. Beaux Arts Brampton is essentially a smoke-free area. However, there are outside areas sufficiently isolated from doorways and foot traffic where smoking is permitted.

Smoking is only allowed outside in designated smoking areas. If a tenant is found to be smoking in a non-designated area, they will be fined \$100 per incident. If more than two (2) incidences occur, the lease will be terminated.

Use of unlawful drugs and controlled substances at Beaux Arts Brampton is prohibited.

Materials:

- Spray painting or use of power or pump sprayers or aerosol products is prohibited in Beaux Arts
 Brampton Studio facilities. Use of toxic, hazardous and/or flammable materials are discouraged
 and can only be used with prior specific written approval of Beaux Arts Brampton Studio staff
 and upon demonstration that the artist seeking to use such materials has been properly trained
 in the use, storage and disposal of such materials.
- 2. Waste materials are to be disposed of in appropriate containers and not to be let to accumulate in corners etc. Washing of brushes, and other tools or equipment should be done in the deep sink in the wash up closet or in your studio sink *where applicable*, not in the bathrooms sink.

Noise:

Heavy noise consideration to the second-floor noise level during public gallery hours is applied. Public Gallery hours are considered:

Wednesday to Friday 1pm-6pm, Saturday and Thursday evening receptions

Other noise levels as it relates to upper business will be discussed should your application be accepted.

Cleaning:

You are responsible for the cleanness of your own studio; studio tenants must pay a cleaning fee twice a year put towards the cleaning of the common spaces shared by all second-floor tenants. Example: Wash up closet & washroom, etc.
